The Contractor shall ensure that the technical and commercial requirements in Clause 17.4.4 of Appendix D, as appropriate, are incorporated and imposed on the Subcontractor and submit for Company's information, at the time of issue, one (1) copy of the bid request for subcontracts and an un-priced copy of the conformed subcontract.

In this respect, you are kindly requested to ensure compliance with the HSE requirements, in particular, but without limitation, HSEMS Procedure(s) and the Driving Procedure in Document KOC.SA.016.

With respect to subcontractor equipment supply, Contractor shall ensure compliance with all relevant Contract documents, including but not limited to, Mobile Equipment Procedure Document KOC.SA.013, State Laws, Regulations, Rules, Ministry Orders, and any other applicable State requirements.

Furthermore, Contractor shall ensure Quality Assurance and Quality Control procedures are implemented for all equipment and machinery utilized and all Works performed.
